power. In addition, he has experience designing and implementing strategic compliance programs and advising on competition law aspects of day-to-day commercial activities, including distribution agreements, pricing strategies, marketing practices, and participation in trade associations.

He has particular experience in sectors such as private equity and sovereign wealth funds; payments and financial technology; infrastructure, airports, and commercial real estate; energy, oil and gas, and renewable energy; consumer goods, beverages, and tobacco; pharmaceuticals and medical devices; and agrochemicals. His experience also extends to e-commerce and technology; packaging and paper; advanced manufacturing; hospitality and tourism; education; publishing; sports and entertainment; and banking and financial services.

His work includes designing privacy governance frameworks and data-mapping strategies; advising on international data transfers, impact assessments, and privacy-by-design requirements; drafting and negotiating data processing and controller-processor agreements; and managing incident response and breach investigations, including regulatory notifications and remediation plans. He also has substantial experience in AI governance and in identifying legal use cases for AI within corporate environments.
