Adolfo served as Secretary of State for Tourism in the XIX and XX Constitutional Governments. During his tenure, Adolfo led the new regulation on a relevant set of public policies: i) travel agencies, ii) hotels, iii) short term rentals, v) touristic animation, vi) online gaming, vii) public marketing strategy for Portugal as a destination (digital marketing, big data, business intelligence, etc).

Mesquita Nunes is currently Lead Independent Director and Vice-chairman of the Board of Directors of Galp Energia, member of the Centro de Arbitragem Administrativa (CAAD)'s arbitration panel and Chair of the World Trade Centre Lisbon Business Club for Smart Cities.

Adolfo combines a broad experience in law, management and public policy with a leadership profile, and that is why he is often requested to advise regulators and corporations on intricate government and regulatory issues, as well as to help decision-makers in critical negotiations and disputes.
