He has also appeared before Parliamentary Committees of the central and regional governments and parliaments of other countries, and has frequently acted as an independent expert providing legal opinions and opinions in inspection procedures, amicable proceedings or arbitration (tax or investment).

Adolfo is the author of numerous publications (books, articles, chapters) in his field, published in the most prestigious publishers and scientific journals worldwide and, on occasion, translated into different languages. In particular, his article “Value Creation: A Guiding Light for the Interpretation of Tax Treaties”, published in the Bulletin for International Taxation 4/5, 2020, was awarded the 7<sup>th</sup> Frans Vanistendael Award for International Tax Law.

He is also a regular speaker at international and national conferences on the subject, both in professional and academic forums (the European Association of Tax Law Professors, International Fiscal Association, IFA Europe, Asia and Latam, IBFD, UN, and Universities all over the world, among others) or in courses organised by tax administrations in different countries.
